OUR VISION & MISSION

Sparsh Hospice, established in September 2011 is an initiative of Rotary Club of Banjara Hills (District RI 3150) under a separately constituted Trust named as Rotary Club of Banjara Hills Charitable Trust. Sparsh takes care of end of life (terminally ill) patients. Sparsh is a non-profit that provides pain and symptom management, psychological and spiritual counselling, as well as food for these patients; striving to make their end comfortable. At present, Sparsh is functional from a 14-bedded premise nestled in the tranquil by-lanes of Banjara Hills, Hyderabad.

The multidisciplinary team comprising of doctors, nurses, social workers, volunteers, and counsellors who offer the necessary medical, emotional, and moral support in preparing for the inevitable. Our services include inpatient, outpatient, and home care (including night home care and Sunday home care). We are serving about 150-160 patients at any given point under the Sparsh banner.

Our philosophy is simple: to give our service users a "serene and dignified departure".

Since pioneering this charitable and non-profit project, Sparsh has seen the growth of palliative care from the stage of very minimal patients in 2011 to a point where a waiting list is maintained for admissions. Breaking the stereotype that palliative care is only meant for cancer patients, Sparsh is now proudly catering to people with life-limiting conditions like dementia, paralysis, neurological conditions, and so on – even in the comfort of their homes.

Today, we are reaching 1000 direct beneficiaries (patients) and indirect beneficiaries (families) annually – with 70% of them coming from below-poverty-line status.

Our long term vision is to be able to continue to provide exceptional palliative care services, free of cost, to terminally ill patients hailing from all sections of the society.

GOVERNING BOARD

The Trust is supported by a Governing Board comprising of 6 members. The Board members come from different backgrounds and are eminent in their own fields. They lay down guidelines for the functioning of Sparsh. Their rich experience has helped smoothen the functioning of a complex facility like a hospice.

Home Care & Outpatient Statistics

Outpatients visit us intermittently for palliative and comfort care (eg: wound dressings, medication, counseling and so on). Patients who prefer to receive palliative and end of life care in the comfort of their homes come under home care. Home care teams with a social worker, nurse, and driver make home visits to this category of patients.

COMMUNITY AWARENESS

We were able to successfully conduct several awareness programs for the following communities:

- 200 members in retired RTC Officers' General Body Meeting
- 150 students at Stanford Degree College, Bhongir
- 400 students at Sri Navabharat Degree & PG College, Bhongir
- 150 students at Sri Lakshmi Narasimha Swamy Degree College, Bhongir
- Around 60 employees of Telangana Secretariat were addressed on hospice and palliative care through the encouragement and support of Mrs. G. Krishnaveni, Secretary to the Vigilance Commissioner.
- 60 Asha Workers across 3 PHCs and Rural Health Departments in Gajwel, Siddipet were sensitized on palliative care.
- 500 members in the Mahila Sangham (directly under the governance of the District Collector) were addressed on palliative care by the Sparsh team in the Nalgonda Headquarters.




PROFESSIONAL DEVELOPMENT & TRAINING


MEDIA RECOGNITION & CERTIFICATIONS

COVID-19 PRECAUTIONS LATE MARCH ONWARDS

The major focus during the lockdown period was to keep our staff, patients and their families safe by following the guidelines and complying with the government's measures. We were able to:

- Train and debrief our staff on COVID-19 measures
- Mobilize select volunteers in the community who had permission to travel, to deliver essentials like medicines to our home care patients
- Receive generous in-kind donations from our supporters in the form of PPE Kits, masks, sanitizers, and other equipment
- Make the in-hospice facility secure by regularly disinfecting the premises
- · Continue our services at a reduced capacity, but not closing our doors to the terminally ill
- · Adapt to tele-health consultations for our home-care patients
- Roll out new policies that prioritized the safety of our staff and patients, eg: No Visitor policy
- · Support our frontline staff with online training courses and certifications in COVID-19 protocol
- Provide temporary pick-up and drop services to our essential staff









During consultation at doctor desk, staff to wear mask and gloves and other PPE.

- 1.Maintain sufficient distance
- Sanitise the room and furniture after visit
 S.First consultation, for new op, homecare or admission. Re OP. 4.Enquire for viral infections

Patient admission:

- 1. Look for covid symptoms
- No paid attenders
 Only one Patient per Room with or without attender
- 4. Avoid admission from red zones
- 5. Admissions from Hospitals are approved , Temperature to be Checked & evaluated for Covid 19 Symptoms
- 6. Declaration Form to be redrafted with additional points related to Covid 19 & Visitors. Feeding of patient without attenders to be assigned specifically to nurses.
- Precautions before admission: Temperature checking for attender and patients COVID symptom assessment. This to be a continuous process in all shifts.
 If symptoms appear post admission the COVID drill to be followed.
- First isolate the person, identify the staff who worked close with the person, and ask for self assessment on daily basis, inform Patient Family, Shift Patient to nearby Hospital . If Family & Patient not Co operating inform Police .)

NEW BUILDING UPDATES

The dedicated efforts of Sparsh were recognized by the Government of Telangana, which has allotted 1.1 acres of land towards our noble cause at Khajaguda, Hyderabad. The new facility will comprise 70 beds and will be constructed at an estimated cost of 15 crores. It will be a state-of-the-art facility that will cater to more numbers of people in the Telugu States and beyond. Although the construction has halted for now due to the pandemic and lockdown, we expect work to pick up soon and the building to be completed by December of 2020.
