

The launch event, held on March 4, 2025, at Sparsh, was graced by Shri D. Sridhar Babu, Hon'ble Minister of IT, Electronics & Communications, Industries & Commerce, and Legislative Affairs, Govt. of Telangana.

A fleet of **7 electric vehicles 4 four wheelers and 3 two-wheelers**, worth ₹57.5 lakhs, was introduced through CSR support.

Medical Director's Desk




Dr Vivekanandam Medical Diirector







Introduction

Sparsh Hospice is a center for palliative care where free of cost symptom relief and pain management services are delivered to the terminally ill through a state-of art inpatient & outpatient facility. Additionally, our homecare supports extended to the needy beneficiaries at their respective homes through 6 fully equipped and staffed homecare vans. Guided by Rotary Club of Banjara Hills Charitable Trust, we prioritize dignity and comfort for those in need, ensuring compassionate end-of-life care. Our services are designed to ensure transparency and full compliance with regulations, including 80G, 12A, CSR 1, and audited financials.

The trust is registered under Registration Act 1908, guided by Indian Trust Act 1882 having Registration no **139/2011.** We are also registered under **FCRA Act** under the social category.

We also have **2 OP clinics** run on fortnightly basis in the two other districts of Telangana (Nizamabad and Karimnagar).



Love, Loss, & Lament

It was my first day at the hospice when I met *Gita, a woman in her late 30s battling stage IV breast cancer. Seeing someone so young, ravaged by a disease I had only read about in textbooks, left me shaken. I had always known that breast cancer is one of the most common cancers in women, but here it was, stark and real before my eyes. Millions are diagnosed with it every year, yet 65% only learn of it at the last stage—a grim reality that played out in front of me. Behind Gita stood her husband, his face a mix of sorrow and helplessness. The psychologist shared her story—once a gold medalist in biotechnology, now battling a cruel illness.

Gita's husband was consumed by guilt over the delayed diagnosis. His pain deepened with fears that their young daughters, still unaware of their mother's illness, might carry the same genetic risk. They remained the fragile thread of hope in their broken world.

They gently helped them face Gita's condition, addressed the husband's guilt and fears, and prepared them to support one another through the difficult days ahead.

That day, after the session, something remarkable happened—the family took their first photo together. It was a simple yet powerful moment of love and strength. Gita's husband, through tears, whispered, "This is probably our last memory together," but counselling had given them the courage to face it as one.

It began with a simple conversation—Gita's husband, filled with love and regret, recalled their wedding and the anniversary they missed due to her illness. Knowing this might be their last, Sparsh Hospice stepped in to create a special memory. The team lovingly dressed Gita in her favorite saree, adorned her with flowers, and tied a Mangal sutra once again. Her husband, dressed as a groom, stood by her side as they celebrated their anniversary—one filled with love, dignity, and deep emotion.

It was a moment to remember—warmth, laughter, and tears filled the room. Gita's husband, once burdened by guilt, now radiated gratitude. He had called himself a failed husband, but that day, he stood tall, embracing the time they had left with love and grace.

Sparsh Hospice gave them more than a celebration—they gave the gift of living fully, even in the shadow of goodbye. In compassionate hands, love found its way through the darkest clouds, turning sorrow into a cherished memory.





A Journey OF Trust

Mrs. Gupta, a 73-year-old naturopathy practitioner, was diagnosed with cancer in 2021 after discovering a lump in her left breast. Despite medical advice to undergo surgery and chemotherapy, she declined these treatments due to her strong belief in alternative medicine, including Ayurveda and Naturopathy. Unfortunately, these methods did not improve her condition, and over time, her pain became unbearable.

Originally from Delhi, Mrs. Gupta moved to Hyderabad to live with her daughter, seeking respite from the harsh weather in Delhi. Her daughter, also a naturopathy practitioner, is divorced and solely responsible for caring for her two school-going children and her ailing mother. This situation left her emotionally and physically exhausted. When she reached out to Sparsh Hospice for pain management, Mrs. Gupta was in severe distress, experiencing extreme pain, nausea, vomiting, weakness, and significant weight loss.

Initially, Mrs. Gupta was reluctant to use allopathic medicines due to her fear of side effects. During initial rapport-building visits, she hesitated to disclose her condition and rejected treatments such as wound care and medications beyond pain patches, even refusing to allow examination of her wounds. However, the Sparsh Hospice team demonstrated unwavering patience and compassion, consistently visiting her home, providing counseling, and working to build trust with both Mrs. Gupta and her daughter. They respected her beliefs while gently explaining the benefits of palliative care.


The team started her pain management with a non-opioid transdermal patch, which provided temporary relief. As her pain increased, stronger medications became necessary. Despite her initial reservations, Mrs. Gupta eventually accepted oral morphine, which brought her significant relief and peace of mind. Today, Mrs. Gupta is happier and places her full trust in the Sparsh team. She now actively reaches out for pain management, wound dressing, and other treatments, demonstrating the profound impact of compassionate, patient-centered care.



Out-patient (OP) consultations can often be a neglected area in palliative care. Sparsh Hospice is committed to provide high-quality care to our service-users who choose to come in periodically for pain management, wound dressings, counselling, and to share a sense of community at the hospice.

Having the extra layer of support can make a big difference to the quality of life. Expert pain management and telephonic medical advice can help to avoid those unwanted trips to hospitals. Currently we extend the services with 3 OP Clinics and they are at different locations:

- a.Sparsh Hospice, Hyderabad
- b. Indur Cancer Centre, Nizamabad



Tele-Health

Tele consultation is all about including patients who are away from us, it also saves the expense and makes it easier for them to receive our services in need. This encourages families and patients in need to come without any hesitation.
